

Dear Customer of Luci Morgan Estate Agency

First of all congratulations on getting you beautiful property listed, I truly wish you every success in selling it, regardless of who you finally instruct to sell it.

I met Luci Morgan, of the Luci Morgan Estate Agency recently and if I were selling a home I would not want her anywhere near my house, myself nor any potential buyers. Ms Morgan can be heard saying in the video she knows I will release the video online, and she still continued to bully me, demonstrating her arrogance and the expectation of there being exactly no consequences.

During the meeting, I was fortunate enough to capture the way she treated me, on video; I, who had done exactly nothing wrong, I just pointed out that she had parked across the pedestrian foot path and that myself, the two mothers with pushchairs behind me and anyone in a mobility scooter would be unable to cross without going off the pavement onto mud and grass.

I politely asked her to move her car.

As you can see here, to the right, her car is very nearly completely off the road and almost totally on the pavement, blocking it completely.



Her verbal onslaught was very aggressive and, in fear of what she may do next, I got my phone out and started to record the events, for my own safety, I must confess I am really pleased I did, though a little disappointed I did not start earlier.

As I passed the car I thought the tirade from Ms Morgan had finished so, believing I was safe, I stopped recording. Sadly, I was wrong. Ms Morgan came back at me, making false accusations using “trigger words” to try and get a reaction. I started recording again as I was feeling both unsafe and threatened again. The split between the two videos is at timestamp 0:16.

Ms Morgan incorrectly uses words like “threatened me”, “abused me” and “attacked me” both in the videos and in her statement to the police, all of which never happened, and because these claims are malicious and untrue, there is, and never will be, any evidence to support her vile and nasty claims.

During the video Ms Morgan repeatedly claims I threatened her, abused her and attacked her, but it can be seen that SHE is the one that is quite literally chasing a member of the public down the street, as he is clearly trying to remove himself from the situation and away from Luci Morgan, of the Luci Morgan Estate Agency.

Ms Morgan **assaulted me** just 30 seconds or so into the video; Ms Morgan puts her arm out to stop me from “getting away,” from my reaction on the video, it is clear I apprehended “immediate and unlawful violence” and Ms Morgan also was aware she had gone too far.

Eventually Ms Morgan gets through to the police on her phone and proceeds to make a false statement including the position of her car (you can “fact check” this on the video), me threatening her, attacking her and totally failing to mention that she had spent nearly 5 full minutes harassing me, despite me repeatedly asking her calmly and politely for her to “please leave me alone” requests that are also very clearly captured in the video.

It is clear from the video, that the aggressor is Ms Morgan and victim is me.

Towards the end of the clip, Ms Morgan can be heard trying to provoke me into a confrontation when she says

“come on little man, why wont you stop if you are going to threaten women like that.”

My response was “I’m trying to get away from you.” Not the response you would expect from a threatening, abusive and attacking man to a woman. A woman who has harassed him for more than 4 minutes, assaulted him and is now literally trying to goad him into a conflict with every potential for it to become a physical conflict.

As you watch the video, I would also like you to consider what response would you have in a similar situation and how much that response would differ, or if the roles in the video were reversed; so I was the one chasing a woman down the street, calling out untrue accusations, goading her and harassing a female member of the public. After all, we are supposed to be in a society with equality, men should be just as protected from harassment as women, regardless of the aggressor.

I am writing to you, to see if you really want to be associated with such a vile lady.

Based on my experience of Ms Morgan, she is a narcissistic bully who clearly thinks the law does not apply to her, but that it can be manipulated by her with lies and false accusations as well as social programming that women are the victims of male abuse for her own needs.
